FINAL PRICE HIKE VOTE SLATED FOR MARCH GENERAL MEETING

Recommendations Reached By Board And Membership

In a long and detailed discussion of proposed price scale increases, more than 60 members of Local 198 gave this important legislation a complete airing at the February general meeting, held in Union headquarters on February 10, beginning at 2 p.m. and lasting until

President Cappalli, who presided, explained that final action will be taken at the March 9 regular meeting, to allow the further discussion and necessary changes.

List Approved

The list of recommendations was approved in principle by the meeting and referred to the Executive Board for further consideration on motion by Ambrose Carroll. Important changes concerning the Ice Show and Weddings have since been made by that Board accord-ing to the latest information furnished to FANFARE.

Detailed Study

Secretary Thompson reported that the list of recommendations was arrived at by the Price List committee after careful study of conditions, complaints of members, and voluntary statements of many interested members who appeared before the Board for the purpose.
The Executive Board further studied the problem thoroughly.

The reasons for needed price changes were outlined by Cappalli before the list was presented, principally the increase in cost of living. Taking part in the discussion were Ed Drew, Tommy Masso, Ben Paris, and other members.

Other Discussion

Purchase of ads in programs for which members are playing was discussed, as well as important Internal Revenue laws concerning self-employment taxes and the status of leaders who may have to register as employers for state and federal tax purposes.

After considerable discussion on changes in acting leaders scales, the meeting voted to retain them as -recommended

tors. We have not even mentioned the Jazz men or soloists.

This is not a complete list. But we would like to raise the hope that some day soon our fair city will find the means to keep such men at home, along with the fine talent which does remain. We sure hate to lose one good man.
