Vote on Wage Changes, Pension Plan Discussion at General Meeting, January 26, 7 p.m. Legion Hall, Cranston

The major business of the General membership Meeting, to be held Tuesday, January 26, at 7 p.m. at the Legion Hall, Cranston, will be wage changes for parade and concert bands, symphonic groups, and general business bands.

Other wage changes to be considered are for New Year's Eve performances, and work on boats and islands.

Another major item on the agenda for the meeting is another open discussion on a pension plan for members that is being developed by a committee headed by Greg Wardson.

The proposed plan is patterned after ideas from the Federation and the successful plan used by Local 802, New York.

A final approval will also be sought at the meeting to excuse President Emeritus Joseph Conte, who served as president for 26 years, from paying annual dues.

Wage Scale -Schedule I

The changes for performance fees for brass, military, symphonic, concert and parade bands (but not including dance bands) has a proposed change that would increase pay for a 2 hour performance by sidemen from \$38 to \$45.

A leader/contractor would receive 10% of the total wages for 15 men plus a sideman's pay.

Schedule II

The change for pop or orchestral concert groups also adds the same pay for a leader/contractor: 10% of the total wages of 15 men plus a sideman's pay.

Schedule III

Performance wages would also increase for symphony (excluding collective bargaining agreements), oratorio, chamber, opera and ballet groups for 2-1/2 hours or less from the current \$90 to \$95.

Rehearsal pay would also increase: Monday through Friday, 2-1/2 hours or less, from \$45 to \$50; Saturday and Sunday, 2-1/2 hours or less, before 6:30 p.m., from \$58 to \$63, and after 6:30 to midnight, from \$68 to \$73.

Schedule V - Class A

Wage increases are also proposed for Class A general business bands, raising the sideman price from 3 hours before midnight from \$75 to \$85; 3-1/2 hours from \$87.50 to \$97.50; and 4 hours, to 1 a.m., from \$100 to \$110.

Single performers are to receive, for 2 hours or less, \$110 rather than the current \$100. Overtime and preheat would have a rate of \$20 per half hour.

Any instrumentalists playing before a band engagement, and who are not part of the band, would receive \$110 for 2 hours or less, a \$35 increase over the current \$75.

Schedule V - Class B

Language proposed that would eliminate among those functions considered Class B: Athletic Events, County Fair, and such ballyhoo services as music for advertising events and on flatbeds.

Schedule V - Class E

The New Year's Eve rate, for a 4-hour engagement would increase from \$150 to \$175 for sidemen, while singles would receive a raise from \$200 to \$225. The special pay for synthesizer would be eliminated.

Schedule V - Class H and I

Sideman performances of 4 hours or less aboard boats would increase from \$110 to \$120 while instrumentalists working solo would receive an increase from \$125 to \$135.

Performances on islands, a maximum of 4 hours within an 8-hour span, would increase from \$125 to \$200. However, travel time (on line 6, for engagements lasting more than 6 hours) would be eliminated.

Schedule VI - Part B

However, general travel time rates for those using a car would increase from 30 cents per mile to 35, and passengers would receive an increase per mile from 10 to 15 cents. Parking anywhere would be reimbursed upon showing of a receipt.

By-Law Changes

Two minor by-law changes are proposed: One would reduce the meeting day notice for regular and special membership meetings from 21 to 15 days, and the other would require members to notify the local of not only changes of address but also changes in telephone and fax numbers.

TIME TO PAY: Annual and Quarterly Dues

With the turning of the New Year, dues for 1999 must be paid.

The annual dues are \$150 plus a \$5 assessment from the Federation; life members pay \$85 plus the \$5 assessment.

Quarterly dues are \$37.50 for full members, and \$21.25 for life members, plus the \$5 assessment.

The assessment was imposed last year by the American Federation. The total was \$10, half of which was paid in 1998; the other half of \$5 must be paid this year.

Treasurer Pazienza reminds members that, according to the by-laws (Article 8, Sec. 9), all work dues are payable "no later than the 15th day of the month following the month in which services were performed."

Any member violating this rule is subject to a fine, no less than \$10, no more than \$25, and/or expulsion from the Federation.

Change of Beneficiary

Since the request in the November Fanfare asking members to update beneficiaries on the local's insurance policy, many changes have been received, Treasurer Pazienza reports. However, he is making another appeal for all to be sure that their beneficiaries are properly listed. Correct information, Pazienza says, will prevent complications in the event of claims.
