By-laws, Wage List Revisions Proposed

Will be Presented at Next General Meeting

The wage list and by-laws committees are working hard to revise their documents. Changes will be presented at a General Meeting at the Union Hall, first floor, at 681 Park Avenue, Cranston on Tuesday, June 3, at 7 P.M.

President Artie Cabral urges all members to attend to hear the recommended changes, discuss them, and revise them as needed. All members should take a serious interest in these matters, Cabral says. "Members are

always very interested in what they get paid on jobs. Here is where the members can have input to get the official wages just as the membership wants. Cabral said: "By-laws are equally important. These are the rules by which the union operates."

The rules are that a vote cannot be taken on the presentation or revision of the resolutions for wage and by-laws changes on June 3. So another General Meeting has been scheduled for July 15 to vote on the changes.

Local Moves Offices To First Floor at 681 Park Ave

The older musicians, especially, find the move of the Union Offices to the first floor at 681 Park Avenue, a major advantage.

"It was difficult climbing the stairs to the second floor," member Glen Jordan (Glen Abrams) said.

The move took place a year ago, in May 2007. Secretary-

Treasurer Ed Plunkett said the cost was about \$10,000, the major expenses being the new telephone system and wiring for the computer. Funds were also expended on new business furniture and carpeting for the office. The office is larger, allowing meetings to be held there so places for meetings no longer have to be rented.

Bank Interest Keeps Local in the Black for 2007

Thanks to interest earned on deposits and monies generated from work dues and fund-raising events, the Local was able to end its fiscal year of 2007 in the black.

Unanticipated expenses associated with the move to the first floor put a strain on the Local's annual budget.

However, work dues paid by members and traveling musicans contributed a healthy chunk of income, \$26,007.

The two Cavalcades during

2007 netted over \$12,000. and the Golf Tournament produced a profit of \$2,352.

These revenues, in combination with membership dues of \$54,375 and various initiation fees, late fees and miscellaneous funds led to a total annual income for 2007 of \$112,573.50.

Expenses for the year totaled \$111,275. for a positive, net cash flow of \$1,297. At the end of the year, the Local had \$72,500. cash on hand, up from \$71,202 at the end

of 2006.

For the first quarter of 2008, finances followed the usual pattern of income far exceeding expenses. This situation occurs every year because many members pay the full year's dues in advance.

Income was \$36,103, in contrast to total expenses of \$22,208, leaving a net gain of \$13,894.

When producer Ralph Stuart died a five years ago, 15 musicians were still owed money for jobs.

Through the efforts of the Local, headed by President Artie Cabral, and the Local's attorney, Paul Phillips, the amount of \$9,667 has been recovered

from the Ralph Stuart Estate. The money will now be paid to the musicians.

A word to the wise: never let contractor's owe you for a job any more than 10 days. Some of these musicians had been owed money since Ralph's death five years ago.

Secretary's Report

S/T provides copies of the minutes of the previous general meeting held on October 30, 2006. Member Art Medeiros moves to accept the minutes. There are several seconds for the motion. The motion carries

Treasurer's Report

S/T does not provide an official report, because the financial statements were published and mailed to members this same day in the *Fanfare* newletter. However, he reviews and summarizes the finances for FY 2006.

Work Dues Reports

S/T reports that the billing method for work dues (and late membership dues) has been changed to a completely computerized system. Compliance among the membership has been very high. He again reviews figures for 2006, noting that \$3,778. was collected in casual work dues in 2006, \$16,598. in symphonic work dues, \$1,180. in theatrical work dues and \$442. in traveling work dues.

Committee Reports

Cavalcade of Bands -- VP reports that the Cavalcade of Bands will be held on May 22. All is proceeding according to plan.

New England Conference – VP reports on the New England Conference of Locals, held March 23-24 in Newport, RI. Much of the conference was devoted to the problem of declining membership. In response, Local 198-457 is extending its membership drive through 2007. In answer to a question, S/T reports that the local has 415 members and that it is imperative to keep the membership above 400, so as not to decrease the local's votes at the national convention from three to two.

Resolutions

Executive Board Compensation ~ A resolution is presented raising the compensation of Executive Board Members from \$25. per meeting to \$50. per meeting. (Resolution attached.)

Late Dues Fees – A resolution is presented raising the late fees for membership dues from \$3.00 per month to \$5.00 per month. (Resolution attached.)

Big Band Scale - A proposal is made relative to wage scales for big bands on Monday and Tuesday evenings, amending Schedule V, Class C of the current wage scale (proposal attached)

A non-binding vote is held on the Executive Board Compensation and Late Fees resolution. Both are approved. However, in compliance with labor laws, the resolutions must be voted on officially at a subsequent general membership meeting.

After much discussion, a consensus can not be reached on the big band scale proposal. Member Sanford Gorodetsky moves to refer the proposal to the Wage Scale Committee, with the advice and counsel of the established big band leaders in the local. EBM Salzillo and others second the motion. The motion carries

VP indicates maximum number of tickets to be available will be 750.

TEMPO Contributions – VP inquires if there is any interest in promoting contributions to the AFM's political action fund, the TEMPO fund. There is a discussion about authorizing a contribution from the General Fund.

Communications

Old Business

Office Assistant & Pension Contributions - Pres provides copies of an explanation from the AFM Pension Fund booklet, indicating that all office employees, whether W-2 or 1099, must participate in the pension plan. EBM Salzillo provides a letter from the AFM Pension fund stat-

ing that only W-2 employees are eligible to participate. EBM Salzillo moves to terminate the services of the current office assistant, Mr. Juliano. On January 1, our parent organization, the American Federation of Musicians, unveiled a revised and enhanced version of its popular web site, www.afm.org.


The site features a new, streamlined appearance. Photos of prominent AFM members scroll across the screen as you are browsing the site.
