Very First Local Annual Budget

DANCE BAND MUSICIANS VOTE LOWER WAGES

Dance band musicians turned out to dominate a General Membership meeting on Tuesday, October 21, to vote for lower wages -- at least on a one-year trial -- than what had been approved in July.

It was on July 15 that the Wage Scale Committee of Ed Drew, Duke Belaire and Carl Hosbond recommended -- and the membership approved -- wages of \$75. per musician for big bands.

But on a resolution by Vice-President Al DeAndrade, the dance players themselves came in to vote to change the pay for Monday and Tuesday nights to \$50.00 per player.

December 16 --- 3:30 - 7:30 PM (Details on Page 14) Allows Members to Review Expenditures and Costs; Defined But Limited Authority for Secretary-Treasurer

For the first time in its 105 year history, Local 198-457 will have an annual budget.

Secretary-Treasurer Ed Plunkett, on the advice of the United States Department of Labor, had first proposed a budget requirement to the By-Law Committee last spring.

The Committee, chaired by Manny Thetonia, reviewed the proposal and reported it out with a favorable recommendation at the June 3 General Membership meeting.

At the July 15 General Membership meeting, the members present voted to adopt the resolution and institute a budget process.

The Secretary-Treasurer is now required to prepare an annual budget and present it to the membership for a vote of approval on the first Tuesday of December -- this year, on Tuesday, December 2.

The proposed budget for 2009 appears in this issue of *Fanfare* on pages 10 through 13.

Based on historical income and expenses over the last several years, the new budget projects total income of \$109,895.00, expenses of \$98,313.96 and a net gain of \$11,581.04.

Under the terms of the new By-Law, the Secretary-Treasurer is authorized to deposit any receipts and to pay any expenses listed in the budget, without having to get a prior authorization from the Executive Board. Any expenses not listed in the budget, over \$200.00, require approval of the Executive Board before they can be paid.

All members are urged to review the proposed budget and to attend the General Membership meeting on Tuesday, December 2, at 7:00 P.M.

The membership also agreed with the jazz band players that on those nights, as has been true for years, \$25.00 is enough pay.

At the September meeting Duke Belaire, a jazz band leader, said that the lower pay allows clubs to afford big band jazz and gives the players a chance to play. DeAndrade made a similar argument for the dance band players.

Belaire, however, would limit the club to only 140 patrons. DeAndrade's plan has no limit on patrons, and allows dancing.

There was considerable discussion before the one-year trial period was suggested and the vote taken.

Art Medeiros made a motion that the dance band pay be \$65.00; Ed Drew seconded. The motion was discussed, but was defeated.

Tony Evangelista said that because of the poor economy, a vote for lower pay might make sense.

John Badessa suggested trying the lower pay for a year. Dick McGuinn so moved, with a second by Tom Breggia. The motion passed.

Musicians who donated their time to play at the Cavalcade of Bands on February 12, May 27, August 20 and October 28, and also those who allowed use of their equipment, will be thanked by the Local with a dinner on Tuesday, November 18, beginning at 6:30 P.M. at Lancellotta's Restaurant, 1113 Charles St., North Providence.

Al DeAndrade, V.P., Named to RIC Hall of Fame

Rhode Island College inducted Vice-President **AI DeAndrade** into its Athletic Hall of Fame at the college's annual Athletic Recognition Dinner and Hall of Fame Induction Ceremony on Saturday, October 4.

DeAndrade, class of '59, starred in men's basketball and soccer at R.I.C.E. from 1955-59. He played freshman basketball at the college in 1955-56, and enjoyed a three-year career as a forward on the varsity team from 1956-59.

He spent his freshman season in 1955 and part of his sophomore season as a back on the men's soccer team, before making the move to the forward position for the remainder of his career. He was a member of the Men's Athletic Association throughout his collegiate career and went on to serve as the official clock operator for RIC home men's soccer contests dur-



ing the sixties. DeAndrade also helped organize and play in many Alumni Soccer Games for over a 15-year period.

After graduation, DeAndrade went on to a 31-year career as an elementary school teacher in Central

Falls. He served as the president of the Central Falls Teachers' Union for 26 years and was the vice president of the R.I. Federation of Teachers for 20 years and treasurer for five years.

He is also an accomplished trumpet player, working as a professional musician since he was 10 years old. After his father taught him to play, DeAndrade played in radio, vaudeville, clubs, hotels, and restaurants, as well as traveling the U.S. with the Ralph Stuart Orchestra.

He has served as the vice president of the Providence Federation of Musicians for ten years.

He earned a bachelor's degree from R.I.C.E. in 1959. He resides in Lincoln, Rhode Island with his wife Roberta '59. They have two children: Alyssa (41) '89 and Brian (38) '98.



Dave McKenna, Legendary Jazz Pianist, Dead at 78

Dave McKenna, who died on Saturday, October 18, at the age of 78, is very much alive in the memories of his family, fans, and friends, and the world music community is abuzz with talk about him, conversations in person and by telephone, emails and faxes. Every means of communication is being used.

"Red" Lennox, of Cumberland, a trumpet player and friend of Dave's since age 10, said that when he met Dave that Dave was playing the piano. His mother, Catherine, a church organist and violinist, had taught Dave the notes on the piano.

"Dave could hear a melody once or twice and he would have it all, notes and chord changes," Red said. Dave's mother had said years ago that "Dave would have everything correct about a musical piece." Lennox commented on that: "Dave had a great memory and great musical ears. You knew at his young age that he would be an outstanding musician."

That was true. Dave was respected around the world. George Shearing once said: "I've tried to play like David and I can't." Oscar Peterson went to hear Dave every night when they worked a Caribbean cruise. "I need a drummer and a bass player to sound like Dave," Peterson said.

Another famed Rhode Island piano player, Mike Renzi, said "Nobody could romp on a piano like Dave."

"He was a one and only," said the reedman Dick Johnson, who was selected by Artie Shaw himself to lead his band.

Dick met Dave in Brockton when Dave was about 19. Lennox said that Dave was playing with Woonsocket bands when he was 15, and when he was 16 Lennox introduced him to the tenorman Chick Cicchetti, who

had played in the Tony Pastor and Stan Kenton bands.

Chick took him up to Milford to play with Boots Mussulli, who had also worked with Kenton. "They loved Dave in Milford," Lennox said, "and Dave loved Milford—he loved the Italian food, on which he was hooked for the rest of his life."

Lennox took Dave to hear Dick Johnson. "In came this tall, lanky guy who looked like a big farm boy," said Johnson. "He sat down at the piano and played a few notes; he instantly became my favorite piano player for life." "We would play a lot of Charlie Parker tunes and be-bop," Johnson continued.

Though the New York Times emphasized that Dave would play a lot of "American Songbook" songs in his solo days, staying around the melody, as a bop player Dave could play as "outside" as anyone.

He became a favorite player in the sessions held in the New York lofts in the late '50s.

Mussulli had introduced Dave to Charlie Ventura and Dave went on the road with him, and then joined the Woody Herman band; he was the pianist in the Zoot Sims and Al Cohn band, and later with the great Dixieland band of fellow Rhode Islander Bobby Hackett. Dave had his years of experience with small and big bands before his solo days.

"His ability defies musical categories," said bassist Marshall Wood and his wife Donna Byrne, who often worked and recorded with Dave in recent years. Scott Hamilton wrote from Italy: "The greatest musician I every worked with. In a class by himself." His bassist for half a dozen years, Frank Tate, who has worked with many great piano players, said: "Dave was an exception. There'll never be another."

"He had a huge impact on music," guitarist Gene Bertoncini said.

Dave died in State College, PA, where his son Stephen and his wife and daughter live. He was cremated there, and his ashes will be spread on Cape Cod where Dave raised his family and where his son Douglas still lives.

Sisters Jean O"Donnell and Pat Savard, and brother Donald plan a memorial service around Woonsocket in the future, and former Woonsocket pianist/vocalist Daryl Sherman, now of New York, plans a memorial there for the New York musicians and fans. All miss David tremendously.

Bill Pandozzi

Bill Pandozzi, a jazz radio DJ often seen as an announcer at the Local's Cavalcades of Bands, died of a heart attack on Sunday, October 12

Bill was a strong supporter of live music and mostly played jazz on his programs at such stations as WAKX and WRIU. His favorites were Frank Sinatra, Count Basie and Ella Fitzgerald.

He always gave notices where union members were playing and did live interviews of musicians, playing their CD's on his program.

Bill was popular with Cavalcade audiences, serving as Master of Ceremonies for many years at every dance of the Providence Federation of Musicians for more than ten years. He also emceed for John Badessa's big band.

Bill had a vast knowledge of music and musicians.

A moment of silence was held in his memory at the last General Membership meeting on October 21, and Al DeAndrade did a tribute to him at the October 28 Cavalcade.

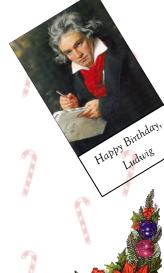

Secretary's Report

Minutes of July 15, 2008 Meeting -- S/T provides copies of the minutes of the previous general meeting held on July 15, 2008. Board Member Worsley moves to accept the minutes. Member Duke Belaire seconds. The motion carries.

Treasurer's Report

As the current financial statements were published in the most recent issue of the Fanfare, S/T declines to provide a financial report. There are no questions from the floor.

Committee Reports

1) Wage Scale Committee - Chairman Ed Drew is unable to attend the meeting. Committee member Duke Belaire acts as temporary chairman. He presents the proposal

to amend the Wage Scale, Schedule VII, "Theatrical Performances", as previously introduced at the General Membership Meeting on July 15, 2008. Belaire questions the insertion of the venue "Casinos" and inquires whether the new scale applies only to theatrical presentations at casinos and not to lounges and social functions. Pres. responds that the proposed use of the word "Casinos" applies only to theatrical performances and not to other types of performances. Belaire moves to approve the proposal. EBM Worsley asks whether, in the new wording, a contractor/ leader from outside the jurisdiction could bring in a big band using the new scale. Belaire replies affirmatively. Some concern is expressed over whether contractor/leaders from outside the jurisdiction could abuse the scale. VP inquires why the proposal eliminates the special scale for Tuesday nights. Committee member Carl Hosbond gives a summary of the origins of the scale, which was intended for 1) weekly engagements and 2) small venues. He explains the committee's view that allowing a lower scale on Tuesday nights is getting away from the original intent of the scale and that the committee wants to return to the original intent of the scale. Committee member Belaire adds that the scale must

apply to the entire local and should not be designed for the benefit of one band. Member Bill Custer states that he thinks it would be a good option to allow a lower scale in large venues, as this might increase the possibility of getting more work for members. EBM Worsley moves to refer the proposal back to committee for clarification of the language. S/T seconds the motion. The motion carries.

Wage Scale Committee - A proposal to amend Schedule V, Class C, "Big Bands" is introduced by VP DeAndrade. Committee member Hosbond explains that the Wage Scale Committee looked at this proposal, but felt that it was counter-productive to the Wage Scale Amendment passed at the July 15 meeting, which changes the big band scale to be the same as Class A, viz., \$75. Committee member Belaire states that the committee does not recommend the proposal. There is a further discussion of the merits of the proposal, as to whether lowering the scale on Tuesday nights would have a positive or negative effect on working conditions for members. VP asks that the proposal be published in the Fanfare so that it can be voted on at the next membership meeting.

Adjournment

EBM Worsley moves to adjourn. EBM Salzillo seconds the motion. The motion carries. Meeting adjourned at 8:28 P.M.

called "Quartette". The software is intuitive and does not require a technical background. It provides a uniform appearance for Local web sites around the country, while at the same time allowing each Local to tailor the information to its own particular needs and requirements.

Additionally, the "Quartette" software provides links

to the AFM's very popular "GoProMusic" web site.

Members can post information about themselves and their groups on "GoProMusic". Then, when the public accesses the Local's "Quartette" - based web site, the potential music buyer is taken to "GoProMusic" listings of only members of the Local, not listings for the

entire AFM.

Plunkett noted that the Local will also be terminating its outside web-hosting service, because the AFM has started to provide web hosting services to Locals at a greatly reduced price, compared to commercial web hosting companies.

The new web site should go online sometime next winter, he added.
