## Nominations Scheduled for Sept. 20

### Overflow Crowd Packs Summer Dance

A crowd estimated at well over one thousand people jammed Rhodes-on-the-Pawtuxet in Cranston on August 16 to hear Local 369 (Las Vegas) and former

President Artie Cabral has announced that the nomination meeting for biennial elections will be held on Tuesday, September 20, at Local headquarters, at 7:00 P.M.

All officers, board member and delegate positions are up for nomination and election. Any musician who has been a mem-

ber of the Local for at least two years is eligible to run for any office.

Candidates who wish to be nominated **MUST** be in attendance at the nomination meeting and should have another member put their name into nomination.

# Resolution Passed

The following resolution was introduced at the General Membership Meeting held on June 14 and was to have been voted on at a General Membership meeting on July 26. Because the Membership Meeting could not be held, due to the lack of a quorum, the Executive Board acted on the resolution at a special Executive Board meeting held on the same evening. The resolution was first amended, then approved by the Executive Board. The final resolution, as passed by the Executive Board, appears below.

## WHEREAS:

United States Law and AFM regulations require that all delegates to national conventions shall be elected and shall not be delegates solely by virtue of office;

## THEREFORE BE IT RESOLVED THAT:

No officer nor executive board member of the Providence Federation of Musicians shall be a delegate to the International Convention of the American Federation of Musicians solely by virtue of office;

## BE IT FURTHER RESOLVED THAT:

The by-laws of the Providence Federation of Musicians shall be revised to reflect this policy as follows:

### ARTICLE IV, Section 2

#### Paragraph (I)

"There shall be elected at the biennial election three (3) delegates to the Providence Central Federated ~~Un-~~ion ~~Council~~, and three (3) delegates to the R.I. State Convention of A.F.L.-C.I.O, four (4) delegates to the New England Conference of Musicians and three (3) delegates to the International Convention of the American Federation of Musicians, provided that no delegate to the International Convention of the American Federation of Musicians shall be elected if there will not be an International Convention held between the date of the current election and the next following biennial election. Alternates to all bodies shall be elected. The term of all delegates shall expire at the next following biennial election. The Executive Board shall determine expenses for attendance."

#### Paragraph (O)

**"Fifth Heading:** Delegate or Delegates to The International Convention of The AF of M (not to exceed three (3)). ~~(President-elect and Secretary / Treasurer by virtue of their offices shall be delegates.~~

### Article V, Section 5

**Section 5.** At a regular membership meeting the Local membership shall determine whether delegates shall attend the A.F. of M. Convention and the New England Conference. If the Local authorizes attendance, the President-elect and the Secretary/Treasurer by virtue of their offices shall be delegates to the New England Conference of Musicians. Delegates shall be elected at the Biennial election. The Executive Board shall determine compensation for attendance, including travel expenses and per diem.

# Meeting Cancelled: No Quorum

The General Membership meeting scheduled for July 26 could not be held when only two members of the Local, plus the Executive Board, showed up.

The total of 7 members did not meet the minimum of 9 needed for a quorum to conduct business.

Two resolutions were to have been considered at the meeting. One required the election of all AFM delegates. The other clarified the collection of work dues on certain engagements.

Following the failure of the General Meeting, the Executive Board immediately held a special meeting. At that meeting, the board was able to approve the resolution requiring the election of all AFM delegates.

The other resolution, which involves a change to the wage scale language, will be resubmitted to the next General Membership Meeting on October 18. It is reprinted below for reference.

They have also provided a quote to digitally photograph the two pictures and print new photographs from the digital file. The cost for this would be \$300.00. In view of the historical significance of the photos, S/T recommends that the Local authorize the digital photographic process. VP moves to authorize the expenditure of \$300.00 on the photos. EBM Worsley moves the amended resolution to remove the officers' *ex-officio* status as delegates to the AFM convention. S/T seconds the motion. The motion carries and the resolution is **approved**.

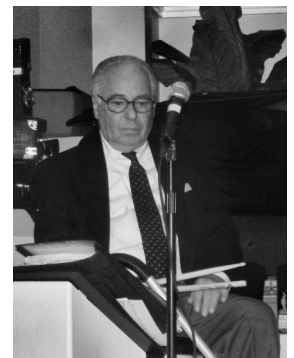

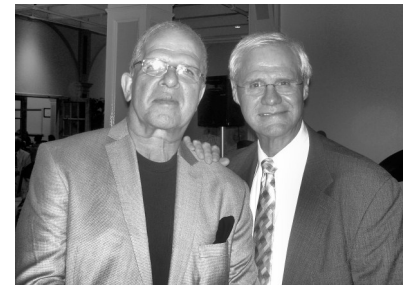
