Resolutions Meeting Called

October 8 Membership Meeting Will introduce By-laws, Finance Proposals

President Artie Cabral has issued a call for a General Membership Meeting on Tuesday, October 8.

The purpose of the meeting will be to introduce several resolutions which will impact the future of the Local.

By-Laws

Several resolutions affecting the Local's By-Laws were introduced at the last membership meeting on May. The resolutions concerned communications, publishing and assessments of fines and late fees. The consensus of the By-Laws committee was that the resolutions needed further study. The resolutions, with appropriate revisions, will be rein-

AFM Convention

AFM Raises Dues

Automatic Pass-Through To Members

At the AFM International Convention, held July 22 - 25 in Las Vegas, delegate voted to approve a financial package which would raise the "Per Capita" tax the AFM charges to Locals by an additional \$10.00. The package also requires Locals to raise membership dues by \$10.00 to pay the additional per capita tax.

The dues increase is expected to generate about \$750,00.00 annually.

The package also included work dues increases on recording and touring, anticipated to bring in an additional half-million dollars for the AFM.

Despite concerns about the potential loss of members, delegates voted almost unanimously for the increase.

TWO ATTEND NEW ENGLAND CONFERENCE

Secretary-Treasurer Ed Plunkett and Brother Art Medeiros attended the New England Conference of Musicians, held in Enfield, Connecticut, April 12 - 14.

Significant time was spent discussing the financial status of the AFM. Both AFM President Ray Hair and AFM Secretary Sam Folio discussed the layoffs of more than 24 long-time em-

ployees of the AFM, as well as the cancellation of paid health benefits for retired AFM employees. The cost saving measures prevented a near financial failure of the national union.

President Hair discussed the status of the AFM-EP pension system. He noted that the fund is healthy and sustainable although, because of the Pension Reform Act of 2006, it must continue to be legally certified to be in the "red zone."

President Hair noted the bleak situation facing major symphony orchestras in the U.S., in particular the extended strike in Detroit and the devastating, ongoing lockout of the musicians in the Minneapolis Orchestra and

Cavalcade Draws Good Crowd

The Cavalcade of Bands, held on May 21 at Rhodes-on-the-Pawtuxet, drew a sizable and enthusiastic crowd.

Over 50 members of the Local donated their services to provide an evening of dancing and listening pleasure to the assembled audience.

Featured in the ballroom was singer Mike Dutra and his "Strictly Sinatra" orchestra.

In the Foyer, new members Corey Pisaturo and Mary Bogan, among others, entertained the throng.

Chairman Al DeAndrade reported that 671 tickets were sold. This compares with 643 tickets which were sold at the *Cavalcade* held in May, 2012.

Total revenue from the event was \$10,660.00 while expenses amounted to \$2,510.00, leaving a net profit of \$8,150.00.

The next *Cavalcade of Bands* is scheduled for Tuesday, October 22.

General Meeting

LOCAL SUFFERS FINANCIAL LOSSES IN 2012

At the General Membership Meeting held on May 7, Secretary -Treasurer Ed Plunkett reported that for 2012 the Local suffered a financial loss of \$22,422.74.

Plunkett further reported that for the first 4 1/2 months of 2013 (through May 10), the Local experienced a loss of \$11,922.48.

Plunkett attributed the losses to the recent salary increases given to officers, as well as to substantial recent increases in leasing costs.

Plunkett advised that the Executive Board, in conjunction with the Finance committee, must develop a comprehensive plan to address the Local's fiscal future. The plan should look at all available options, including

- Increasing revenue from fund-raising events
- · Reducing office expenses
- · Salary adjustments
- Membership dues increases

On a question from the floor, Plunkett responded that the Local has enough funds to hang on for a year or two, but the problem must be addressed this year in order to assure the Local's long-term survival.

He also noted that the AFM is planning a \$10.00 increase in dues for 2014. Regardless of the Local's actions, dues for 2014 would rise by at least \$10.00.

By-Laws

By-Laws Committee Chairman Sandy Gorodetsky introduced three resolutions which would change the existing by-laws.

One resolution would extend the time frame for late fees from 15 days to one month.

The second resolution would make the Local's website the official repository of information, with the newsletter being printed only intermittently.

The third resolution would make email the Local's official method of communication.

After some discussion, the resolutions were referred back to the By-Laws Committee for further study.

In a show of support reminiscent of a bidding war, delegates from more than 130 Locals, Player Conferences and Locals Conferences pledged over \$60,000.00 to support sister Local 30-73 (Minneapolis/St.Paul), which has been devastated by the lockouts of both the Minneapolis Symphony Orchestra and the St. Paul Chamber Orchestra.

(Ed. Note: The SPCO lockout has since been settled.)

In a nod to technology, this was the first year the AFM convention was broadcast live on streaming video. It was possible to watch the entire convention online from a computer attached to the internet.

Due to financial concerns, Local 198-457 did not send any delegates to the convention.
