## **Hosbond Wins Board Seat**

#### DeAndrade, Worsley Re-elected

At the biennial election held on Sunday, November 10, 2013, Brother **Carl Hosbond** was elected to a term on the Local's Executive Board.

It will be the first Local 198-457 office for the saxophonist / arranger.

Vice-President Al DeAndrade was re-elected to his position, as was Executive Board Member John Worsley. President Artie

Cabral and Secretary-Treasurer

### **Committee Softens Proposal**

At the annual Budget Meeting held on December 3, 2013, a resolution designed to save the Local from bankruptcy was approved by the membership.

The Finance Committee, under the leadership of Chairman Jason Bianco, reviewed, studied and revised a resolution introduced at the October 8 General Meeting, which had addressed the Local's ongoing fiscal problems.

The original resolution had proposed:

- Pay cuts of \$3,000.00 apiece for the three officers;
- Require officers and board members to pay membership dues:
- A graduated increase in membership dues over the next five years, starting at \$200.00 in 2014 and rising to \$240.00 in 2018.

Under the original resolution, about half of the Local's annual deficit would have been made up by the salary cuts for officers. The other half would come from the increases in membership dues.

#### Revisions to Proposal

The Finance Committee decided to keep the pay cuts and dues requirements for officers. However, instead of eliminating the cuts after two years, the restoration of the President's and Secretary-Treasurer's salaries to current levels would be spread over four years. The Vice-President would continue to be paid as a Board Member, rather than a salaried employee.

The dues increases underwent additional revisions:

#### Limit of \$192.00

Avoiding a floor of \$200.00 for 2014, the committee chose to limit the 2014 increase to \$192.00 for regular members and \$132.00, instead of \$140.00, for Life members.

#### Biennial Increase

Thereafter, dues increases would occur every two years (rather than every year), topping off in the year 2018 at \$220.00 (down from proposed \$240.00) for regular members and \$160.00 (instead of the proposed \$180.00) for Life members.

Bianco noted that the additional dues amount included a \$10.00 per capita increase which

# Fund-Raiser a Success

A new type of fund-raising event has proven profitable for the Local.

On February 9, the Local held a combination jazz concert and dance at the Marriott Hotel in Providence. The featured performers were two tenor saxophonists who are both Rhode Island natives – Harry Allen and Scott Hamilton.

Backing them up were a rhythm section consisting of **Gray Sargent** (Local 9-535) on guitar, **Jim Gwin** (Local 9-535) on drums and **Marshall Wood** (Local 198-457) on bass. Sargent and Wood are full time members of vocalist Tony Bennett's backup trio.

A new fund-raising committee was formed to produce the event. It consisted of President Artie Cabral, Vice-president Al DeAndrade and Board Member John Worsley.

Admission was \$20.00 per person and there were 208 paid admissions, providing \$4,160.00 in gross revenue. Expenses, which had not been finalized at the time of publication, are expected to amount to about \$2,200.00, leaving an anticipated profit of just under \$2,000.00. Salaries for the band alone were \$1,775.00.

The committee is working on planning other fund-raising concerts which they hope will be as successful as this one.

# 2013 FINANCIAL REPORT SHOWS ANOTHER LOSS

Secretary-Treasurer Ed Plunkett has announced the Local's annual financial results for 2013.

For the year, the Local had income of \$115,059.18 and expenses of \$129,155.79, for a net **loss** of \$14,096.61. This follows a loss in 2012 of \$22,442.74.

The Local started the year with cash reserves of \$89,402.44 and ended the year with \$75,532.23.

Plunkett noted that he had been anticipating a loss of about \$23,000.00 for the year. However, many members paid their 2014 full-year dues in December, 2013. Over \$10,000.00 in early dues was received in December. Without that influx of cash, he commented, the year-end loss would have been closer to his prediction of \$23,000.00.

Plunkett opined that the newly enacted financial reforms will bring the Local's finances back into balance by the end of 2014.

Hosbond received 83 votes and incumbent John Worsley got 81, placing them in the winning column. Challenger Joe DeMarco got 66 votes while long-time incumbent Dick Salzillo received 50 votes.

In the Vice-presidential race, incumbent Al DeAndrade won reelection with a total of 82

the AFM requires all Locals to pass along to members. Even if no dues changes were voted in, he explained, membership dues would have still gone up by \$10.00 to pay the AFM per capita increment.

In order to expedite the proceedings, Chairman Bianco moved to amend the original resolution from October 8 to reflect the changes made by the Finance Committee. Executive Board Member Richard Salzillo seconded the motion. The motion carried on a voice vote.

Brother **Justin Holden** moved for a vote on the amended resolution. Board Member Salzillo again seconded and the motion carried. After some discussion, Brother **Joe Foley** requested a paper ballot. The final vote tally was 16 in favor and 8 against. With that, the resolution was **adopted**.

Chairman Bianco expressed his thanks to all the members of the Finance Committee and to the additional brothers and sisters who served temporarily on the committee to assist with the consideration of the proposal. #### • By-Laws Changes

By-Law Committee Chairman Sandy Gorodetsky reported out three resolutions which had been introduced at the May 5, 2013 General Membership Meeting and which were subsequently

amended at the October 8, 2013, meeting.

The first would extend the time period before late fees are applied to membership dues from 15 days to one month. This is in line with practices of other Locals and is also more consistent with the Local's computerized accounting systems.

The second resolution would make the Local's web site the repository of all official documents and notices. It would lessen the requirements on the Local's newsletter as a means of communication and only require the printed newsletter to be published two times a year.

The third by-law resolution would make email a valid method of providing notice to members. While email had originally been proposed as the only means of notice, the committee felt that it was necessary to maintain other forms of communication, such as the newsletter *Fanfare*, individual notices through the U.S. Mail, or personal service

The committee reported all three resolutions **favorably**. Brother Holden moved to vote on all three By-law resolutions as a single package. The motion was severally seconded and carried. Executive Board Member John Worsley then moved to vote on the By-law resolution package. Brother Bianco seconded the motion. The motion carried and the three resolutions were **adopted**.

#### 2014 Budget

Secretary-Treasurer Ed Plunkett presented the annual budget for 2014. He noted that the budget was based on the Local's 2013 financial experience and assumed nothing about the

passage of any financial reform package. As a result, the proposed budget projected income of \$108,777.00 and expenses of \$132,523.00, leaving an anticipated **loss** of \$23,746.00. Brother Holden moved to amend the proposed budget to be consistent with the financial resolution which was just approved. Brother Bianco seconded the motion and the motion carried.

Brother Holden then moved to approve the budget as amended and his motion was severally seconded. The motion carried and the amended budget for 2014 was adopted.

Plunkett stated that he would post the revised budget on the Local's web site. He added that he was hopeful that, with the financial reforms just passed, the budget would now be in balance.

## "Bill-Payer" Checks Causing Late Fees

One of the newer trends in electronic banking is the "Bill-Payer" feature. This high-tech system allows customers to pay their bills on-line through their own bank, avoiding postage fees and having the ability to specify exactly when to pay the bill.

A number of Local 198-457 members have been taking advantage of the new technology to make membership dues payments.

A work of caution needs to be given, though.

Even though the bank customer requests payment on a certain date, that request does not necessarily mean that the payment will be received by the Local on time.

First of all, there is no electronic transfer of funds to the recipient. That is, the bank simply mails out a paper check to the Local. There can be delays in delivery simply because of post office issues.

Also, if several bank customers are making payments to the same recipient (e.g., the Local), it

is not uncommon for the bank to hold all the payments until the last one is scheduled, and then mail all the checks together in a single envelope.

On a number of occasions, members have specified payments to be made on the last day of the dues cycle. But because of mail or other delays, the checks arrive at the Local's office late, thus triggering late charges.

In an effort to avoid late fees, the Local strongly urges members who use "bill-payer" services to schedule payments at least one week before late charges would otherwise be incurred.

Thus, the scheduled payment dates should be as follows: For **first** quarter dues,

- not later than **January 24**; For **second** quarter,
- not later than **April 23**; For **third** quarter,
- not later than **July 24**; and for the **fourth** quarter,
- not later than October 24.
