# Local Rejoins State AFL-CIO

Our local has rejoined the Rhode Island state branch of the AFL-CIO, after an absence of almost twenty years..

It means that all of our local's bands and all of our musicians will be protected by the Rhode Island AFL-CIO, according to **George Nee**, President. We will have the help and support of the state AFL-CIO in any union matter.

The negotiations in this relationship were accomplished by **Scott Malloy**, labor relations professor at URI and Board Member **John Worsley**. Local 198-457 President **Artie Cabral** met with Mr. Nee to confirm the arrangement. As an incentive to the Local, President Nee appointed President Cabral to the AFL-CIO Executive Board.

The Local had left the AFL-CIO some years ago because of the high cost of the per capita dues. However, Cabral and Nee were able to reach an agreement where the Local only pays per capita dues for those members covered by a collective bargaining agreement (CBA). This represents a significant cost saving to the Local, while giving the Local the full benefit of AFL-CIO membership.

# Changes Proposed to Survivor's Benefit, Life Membership

Two important resolutions were introduced at the General Membership Meeting held on Monday, October 27. The first proposes elimination of the Survivor's Benefit, which has become a financial drain on the Local, while the second seeks to allow all years of service in the calculation for Life Membership, even if there were gaps in membership.

· Survivor's Benefit

The resolution to eliminate the Survivor's Benefit was developed by the Finance Committee (Jason Bianco, Ed DiMartino

and **Greg Wardson**) after the Local experienced serious losses, both financially and personally, in 2014. This year the Local has already paid out \$13,000.00 in death claims, leaving only \$16,000.00 in the Survivor's Benefit account.

Meantime, the liability to the Survivor's Benefit Fund increases as the membership continues to age.

Fearing the worst, the Finance Committee's resolution proposes to eliminate the Survivor's Benefit as of July 1, 2015. At the

The impetus for the "Special" meeting was the recent dues increase, which was approved at the December 3, 2013 meeting

All of the Local's officers were present, along with the Local's newly-appointed AFM International Field Representative (IR) **Barbara Owens**, who is a past President of Local 9-535 in Boston, a native of Providence and a former member of Local 198-457. IR Owens said she would answer any questions that might be raised about the AFM's position.

Brother **Ian Greitzer**, Chairman of the RIPO Player's Com-

President Cabral and Vice-President Al DeAndrade were invited to the AFL-CIO's COPE convention on September 19, which was held at the Rhode Island Convention Center. While the purpose of the COPE convention is primarily to endorse political candidates, Cabral and DeAndrade received a standing ovation from the delegates when George Nee introduced them and our Local as the newest union to join the AFL-CIO.

President Cabral commented that he hoped the Local's participation in the AFL-CIO will encourage our sister labor unions to hire union bands and union musicians for their social events. Two Members Honored for Lifetime Achievements

Two members of this Local, "Saucy Sylvia" Mureddu and President Artie Cabral have been honored for their lifetime achievements.

"Saucy" was honored by the RI Broadcasters Association, at its annual banquet on May 9, for her 70 years in radio, and her late husband, Mike, was commemorated for researching, writing and producing her show for 27 years.

How did it feel to be so honored? "Indescribable," according to Saucy.

"It was a very big honor," Saucy added.

The Canadian native started her career in Cincinnati and continued on in Rhode Island. "I just loved radio," she said

President **Artie Cabral** was inducted into the RI Heritage Hall of Fame in a ceremony held on April 26. He said the award "caught me by surprise. I never expected it, but I am very proud to have been so honored."

In his acceptance speech, Cabral described a childhood encounter with the great bandleader Duke Ellington and how that meeting shaped his life as a professional musician.

mittee, spoke on behalf of the orchestra members.

Greitzer explained that the orchestra members felt the dues increase was too large, and that they were not consulted before the increase was implemented. Brother **Gabe Langfur** reiterated Greitzer's position.

Brother **Jason Bianco**, chair of the Local's Finance Committee stated why the dues increase had to be so drastic. He noted that for the past two years that the Local had suffered significant deficits and that serious measures had to be adopted so that the union would not "go into bankruptcy."

Treasurer Ed Plunkett said that for the past two years the deficits were in the \$23,000---\$24,000 ranges.

Plunkett continued to state facts:

 The three officers (President, VP, and Secretary-Treasurer) took major pay cuts of \$3,000 (which in DeAndrade's case put him back to Board status);

- all officers and board members had to begin paying dues;
- the officers renegotiated the lease with the owner of the property where the office is located, saving \$3,000;
- and a part-time employee retired, saving another \$2.500.

Even with those cutbacks, Plunkett continued, there was still an \$11,000 shortfall, requiring a large dues increase.

President Cabral added there had not been any change in the Local's "per-member" income since 1998. He said all increases since 1998 had been pass-through surcharges from the AFM, and that the additional money had been sent directly to the AFM; it did not benefit the Local.

Vice-President DeAndrade noted that the Local runs three dances (*Cavalcade of Bands*) per year, plus a Golf Tournament, to bring in funds and that he, President Cabral and Board Member John Worsley had run a jazz concert which produced \$2,000.

"We are doing what we can to keep the Union solvent," Board Member Worsley commented.

Plunkett noted that all members should have been aware of the financial difficulties and actions taken, because there were stories in several of the Local's *Fanfare* newsletters prior to the December 3 meeting. He demonstrated copies of the newsletters to document his statement.

Brother **Sandy Gorodetsky,** taking a philosophical view of the situation, exhorted those present to consider their dedication to the union cause, saying that when people join an organization they should be "loyal" to it in both good and difficult times.

There were many questions from the floor, with IR Owens and officers trying to respond to as many as possible. After considerable discussion, Brother Greitzer moved to end the discussion and thee meeting was adjourned.

### **Resolutions**

The following resolutions were introduced at the General Membership Meeting held on Monday, October 27 at 7:00 PM at Local Headquarters. They will be considered at the next General Membership Meeting on **Tuesday, December 2**.

## RESOLUTION TO ELIMINATE OR CHANGE THE SURVIVOR'S BENEFIT

WHEREAS the financial status of the Local is still in a precarious position, despite several financial reforms; AND,

WHEREAS the income from the Local's fund-raising activities, which are the main source of financial support for the Survivor's Benefit Fund, have continued to decline over the last several years, to the point where the fund-raisers alone are no longer able to sustain the Fund; AND,

WINCREAS the monies left in the Survivor's Benefit Fund are only \$16,000.00, while the potential liability for the Local is between \$100,000.00 and \$200,000.00; AND

WHEREAS if the number of deaths in a given year were to exceed the balance left in the Survivor's Benefit Fund, the Local would be forced to default on its obligation and perhaps face legal action or bankruptcy,

BE IT THEREJORE RESOLVED THAT the Survivor's Benefit shall be eliminated as of July 1, 2015;

BE IT FUNCTION RESOLVED THAT the Local shall honor any claims for members who die in good standing before July 1, 2015, provided that the claim is filed no later than June 30, 2016;

BE IT FUNCHER RESOLVED THAT the Secretary-Treasurer shall be directed to deposit any outstanding funds remaining in the Survivor's Benefit Fund after July 1, 2015 into the Local's Reserve Fund;

BE IT JUNTHER RESOLVED THAT, effective July 1, 2015, the PFM By-Laws shall be amended to reflect this change as follows:

- i. ARTICLE XVI shall be DELETED in its entirety;
- ii. ARTICLE XVII shall be retitled as ARTICLE XVI:
- iii. ARTICLE XVIII shall be retitled as ARTICLE XVII;
- iv. ARTICLE XIX shall be retitled as ARTICLE XVIII;
- V. ARTICLE XX shall be retitled as ARTICLE XIX;
- vi. ARTICLE XXI shall be retitled as ARTICLE XX;

BE IT JUNCH RESOLVED THAT, effective July 1, 2015, the Secretary-Treasurer shall be directed to delete any other reference to the Survivor's Benefit which may exist in the By-Laws.

BE IT JUNTHER RESOLVED THAT the officers of the Local shall be directed to explore the acquisition of a group term life policy for the membership and to report their findings back to the membership at a General Membership Meeting to be held no later than June 30, 2015.

## RESOLUTION No. 2014 - 02 A RESOLUTION TO CHANGE THE REQUIREMENTS OF LIFE MEMBERSHIP

WHEREAS the AFM, at its 2013 International Convention, changed its requirements for Life Membership from 35 years of "CONTINUOUS" membership to 35 years of "ACCUMUATED" membership; ARA.

WHEREAS the bylaws of the Local still refer to 35 years of "CONTINUOUS" membership and thus are not in agreement with AFM by-laws and policy; APA

WHEREAS there are members of the Local who have 35 years of "ACCUMULATED" membership but are currently ineligible for Life Membership because of an interruption in their membership,

BE IT THEREFORE RESOLVED THAT the requirement for Life Membership shall be changed from 35 years of "CONTINOUS" membership to 35 years of "ACCUMULATED" membership;

BE IT JUNCHER RESOLVED THAT the PFM By-Laws shall be amended to reflect this change as follows:

#### ARTICLE II MEMBERSHIP

Section 6. The Executive Board is empowered to grant life membership, upon written application, to any member having reached the age of seventy-two (72), who shall have accumulated at least thirty five (35) years been a member of membership in the American Federation of Musicians continuously for at least thirty five (35) years and who shall have been a member of the Providence Federation of Musicians continuously for the immediately preceding five (5) years, ......

## **Fund-Raisers Boost Local's Treasury**

The Local enjoyed another successful fund-raising season, as two fund-raising dances, one on May 20, the other on August 5, raised a combined total of \$7,239 for the local's treasury. In the meantime, the results of the latest *Cavalcade of Bands* on October 28 are still pending.

The musicians who donated their time to play can be proud of the service they rendered and have the thanks of their Union brothers and sisters.

Added to this was a successful golf tournament held on August 26, raising another \$3,365.00 for the union.

#### May 20 Cavalcade of Bands

The ticket receipts raised \$6,645 even though there was a confusion about exactly how many tickets were sold at the door. Expenses for such items as hall rental, police and fire coverage, postage for mailings, cost of parking attendant, chair's expenses, came to \$2,880, leaving a profit for the local of \$3,765.

The Ballroom bands were: Art Medeiros, and Dan Ferreira and The Meadow Larks. Tom Rotondo's group played the breaks. In the Foyer were Lloyd Kaplan

and his AristoCats, and a group of singers with their accompanists: Ginny Conley and Bill Moretti, Angela Baccari and Denise DeCaro with Mike Renzi, Terri Giviens with Yvonne Monnett and Tony DelSignore with Johnny Badessa's band.

The announcers were: **Bill Melone**, **Johnny Nardo** and **Larry Perlman**. The chair was **Al DeAndrade**.

#### • August 5 Summer Dance

**Al DeAndrade** directed this one, too. The profit was \$3,474. Tickets sales raised \$5,300. Expenses were \$1,826.

Dan Ferreira played this one also in the Ballroom, again with Tommy Rotondo's group playing the breaks. Steve Bianchi was the announcer. In the Foyer were The Dixieland Pops with Patsy Kettel singing; Shawnn Monteiro sang with Kent Hewitt at piano, along with Paul DelNero and Artie Cabral; The Dick Lupino Band with Mary Andrews on vocals and Ginny Conley with Bill Moretti.

#### August 26 Golf Tournament

The Golf Committee, headed by **Alex Mansour** and **Al DeAndrade**, feel they had a successful tourney on August 26 at the Valley Country Club, Warwick: the golfers had a good day and \$3,365.00 was raised for our Local.

The total income was \$10,550 from dinners, the tournament and golf signs. Expenses for the banquet, green fees and raffle prizes came to \$7,185.00.

The first place team was the group of Ed DiMartino, Mike Calise, Jim Wardick and George Benjamin. The second place team was Mark Arnold, Joe Lovett. Peter Halla and Steve Fullerton. The third place team was Greg Wardson, Dennis Clark, Rick Dion and Ron Lavoie. Closest to the like was Steve Stapleton; closest to the pin were Steve Fullerton and Dennis Clark. The longest drive was hit by **Jim Wardick** — 297 yards — and Bill Custer — 277 vards.

#### October 28 Cavalcade of Bands

Final results are not yet available for the October 28 Cavalcade, but over 300 tickets were collected at the door. The gross revenue, before expenses, is expected to total more than \$5,000.00.

same time, the resolution directs the officers to explore other available options, such as a group term life policy. S/T Ed Plunkett noted that the Local has already made some inquiries, but so far has not found anything satisfactory. He noted that because more than half the membership of the Local is over the age of 60, it is difficult to find an insurance policy.

The resolution was referred to the Finance Committee for further study and review.

#### Life Membership

The second resolution, which was submitted by Brother **Lloyd Kaplan**, seeks to bring the Local's by-laws into compliance with the AFM's by-laws for the purpose of Life Membership.

In 2013, at its International Convention, the AFM changed the requirement for Life Membership from 35 years of "continuous" membership to 35 years of "accumulated" membership.

Thus, a member could change his or her status to "Life" membership, as long as that musician had 35 total years of membership in the AFM, even if there were a gap in membership.

Kaplan's proposal does not change any of the Local's other requirements for Life Membership — namely, a member must have attained 72 years of age and have been a member of the Providence Local for at least 5 years.

The resolution was referred to the By-Laws committee.

Both resolutions will be considered at the December 2 Membership Meeting



## Max Herman Passes at Age 99

#### Former President of Local 47 was Rhode Island Native

Max Herman, a veteran of the big bands of the 1930's and 40's, later President of Local 47, Los Angeles, and a former member of Local 198-457, passed away at his home in Sherman Oaks, California on June 1.

Herman was just one month short of his 100th birthday

A contemporary of Rhode Island trumpet legend Bobby Hackett, Herman was born on July 1, 1914 in what was then a farming community in North Providence, known as Woodville, along Woodward Road.

Active and athletic throughout his life, he played a full round of 18 holes of golf until he was 96-years-old. In fact, he would frequently write to the Providence Local that he "golfed his age."


He also was a great lead trumpet player, taking his first lessons at 8-years-old from Alexander Billinkoff, the same teacher with whom another great local trumpeter, Guy Chiaverini studied. "He (Billinkoff) must have been a great teacher," said President Artie Cabral, who remembers the great playing of both Herman and Chiaverini.

"Joe Conte (former Local 198-457 President) was a contemporary also," Artie added, "and there were great reunions when Max came to Providence to visit Joe. Both were union Presidents, Joe here and Max in Los Angeles."

Max was 13 when he played his first professional job. He played trumpet and Bobby Hackett played banjo and ukulele; Nick Fatool played drums.

"Bobby always had a restrained elegance about his playing," Max remembered in his autobiography, First Trumpet. "Listen to Bobby on those great LPs he made for Jackie Gleason," Max said.

Max moved up the musical ranks quickly, playing lead trumpet in Perry Borelli's group, one of the most popular bands around Rhode Island at that time. Max played in some other bands, and then latched on to a national career with Bob Crosby's highly popular Dixieland/ Swing band.



On the Crosby band Max met the drummer Ray Bauduc and the bassist Bob Haggert, three great trumpet players Mugsy Spanier, Billy Butterfield and Yank Lawson, vocalist Doris Day, the arranger Ray Conniff (a native of Attleboro), the tenor saxophonist Eddie Miller, the trombonist Buddy Morrow and the pianist Jess Stacy, along with other fine players of the era.

The Crosby band moved to Hollywood and played in several films. That's how Max got to the West Coast and began to get his film experience.

Max played in a Coast Guard band during World War II, and

after the war found various new opportunities in California as television work began to replace radio programming.

He considered Las Vegas and Hollywood to be centers of the music business, and so he wrote in his book: "After World War II, when the big band era faded, Hollywood (and Vegas) offered a variety of jobs in the entertainment field. Many musicians moved west to seek studio employment in the thriving motion picture field, the recording, radio and television industries. Vegas became a music center, too. Over 90 percent of the musicians there were employed. Now Las Vegas is almost a ghost town for live music. Even big productions are using recorded music-usually taped in Europe."

Max spent the postwar years as a studio musician, working in movies, television and show bands, operating his own music publishing businesses -- Fiesta Music and Herman Music -- and serving his union, Local 47, Los Angeles.

In 1956 Herman was first elected as Vice-President of Los Angeles Local 47. He ran for President in 1973 and was elected. He served in that capacity from 1973 until 1982 and again from 1990 until 1993, when he retired

Herman had one other achievement in the postwar years. In 1950 he entered a contest held by Local 198 to name this newsletter. He won with his submission of *Fanfare*. And so it is: Max Herman will always be remembered in Rhode Island.
