Membership Meeting

Resolution Will Halt Further Dues Increases

MPTF Increases Co-funding

The Music Performance Trust Fund (MPTF) has announced that it will increase the percentage it contributes on all general MPTF performances to 50%.

Previously, the Fund offered to contribute 30% on ordinary concerts, 40% for senior centers, and 50% for educational concerts.

Now, the percentage will be the same for all events across the board.

It is the hope of the MPTF that the increased contribution rate will spur sponsors into holding more events, particularly those sponsors who are "on the fence" about participating. The new rate is effective immediately and will last through the current MPTF budget year, which ends April 30, 2019.

Educational Initiative.

The MPTF has also created an "Education Initiative", which will be funded at 100%. Applicants must submit a proposal, explaining the purpose of the program and how it will benefit educational goals, together with the details of the concert or concerts to be given. Once the proposal is accepted by the MPTF, the leader/contractor

At the General Membership Meeting held on September 25th, President Ed Plunkett introduced a resolution to rescind the dues increase scheduled for January, 2020, and halt any further dues increases.

In January, Plunkett had introduced a resolution which would have canceled any increases and rolled membership dues back to 2017 levels.

That resolution was passed unanimously by the membership at the April 17th membership meeting.

However, a requirement in the AFM By-Laws mandates that any dues decrease must be approved by the International Executive Board (IEB) of the AFM.

At its June 2018, meeting, the IEB deferred any action on the Local's resolution, leaving the current dues structure in place.

Plunkett's new resolution takes no action on the April enactment, but cancels the future increase in 2020, so that the membership dues will at least remain at 2018 levels. IEB approval is NOT required for the new resolution.

The resolution is printed in full on page 5 and is also posted on the Local's web site, in the "Members Area". It will be voted on at the annual budget meeting on November 20, 2018.

Music Festivals

President Plunkett had planned to devote a substantial portion of the meeting to discussion of the summer classical music festivals in Rhode Island.

To that end, invitations had been sent to Pat Hollenbeck, president of Local 9-535, Joe Messina, president of Local 400, and to all the musicians who performed at this year's summer music festivals.

The weather, however, proved to be too much of an obstacle. A severe rainstorm prevented the guests from getting to Providence and probably discouraged most of our Local members from attending as well. In the end, only five members of the Local were able to get through the bad weather for the meeting.

However, Plunkett did speak at some length about the issues around the summer music festivals and emphasized the importance of filing standard AFM contracts.

Other Business

Secretary-Treasurer Vern Graham presented the Local's financial report for the 2nd quarter (April, May, and June) of 2018. It showed a net gain for the second quarter of \$927.76. Total cash assets at the end of the second

Concerns over Summer Music Festivals

The officers of our Local, as well those of other Northeast Locals, have become increasingly concerned over the summer classical chamber music concerts in Rhode Island.

The summer festivals supplement, or augment, their primary players with local musicians from the New England / New York area. While some of the "extras" are from our Local, many are from Local 9-535 in Boston, Local 400 in Hartford and Local 802 in New York City.

Several incidents this past summer sparked the concern among the officers.

First, the Kingston Chamber Music Festival (KCMF) brought in internationally acclaimed violinist Hilary Hahn as soloist in one of the programs.

However, the Kingston Festival was about to allow an outside entity to make a video recording of the events, without filing valid AFM recording contracts. Under AFM recording contracts, the musicians would

Meantime, the "Musician Fest" program continues to be available. "Musician Fest" provides 100% funding, up to a limit of \$200.00, for events held to serve senior citizens, such as in senior center, nursing homes, veterans' centers, etc. Members are encouraged to take advantage of this program.

have been entitled to recording scales, in addition to their performance fees.

Thanks to a concerted effort by the AFM's Electronic Media Services Division (EMSD) in New York, in conjunction with Local 198-457, the unauthorized video recording was avoided.

Nonetheless, the lack of AFM live performance contracts left the Local and the AFM in a weak negotiating position.

The second area of concern involves the Newport Music Festival (NMF), where a new management team has taken a harsh attitude toward local musicians. In prior years, the NMF always paid the work dues for the musicians, as a good will gesture. This year the new management refused to continue the practice, so that the performers had to pay the work dues out of their own pockets.

Thirdly, both the Newport and Kingston Festival have sent the musicians contracts which are designed totally to protect the management. Under these contracts, the musicians not only lose protections which they are guaranteed by AFM contracts, they forfeit some worker rights provided to them under state and federal labor law.

The Local's and the AFM's primary interest, at this point, is to protect the performers against unauthorized, and uncompensated, recording of their performances.

To this end, Local 198-457, in conjunction with the other Northeast Locals, is launching a drive to encourage all musicians who play in any of the summer festivals to insist on a valid AFM performance contract.

All AFM performance contracts strictly prohibit the recording of a performance without a separate AFM recording contract being in place.

If all the performers insist on an AFM contract, then the Local and the AFM can step in to prevent unauthorized recordings and to promote contractually-protected recordings, where the musicians are paid the proper recording scale.

One need only look back to 2017, to the disastrous Newport Contemporary Music Festival, to see the results of working without a "union" contract. In that debacle, a hundred players lost nearly \$170,000.00 in wages. Because no "union" contract had been filed, the Local was unable to intervene on their behalf and the musicians were left to fend for themselves.

Local 198-457 has developed a set of policies and procedures which we recommend all musicians follow in dealing with the summer music festivals.

Policy & Procedure Guidelines for RI Summer Music Festivals

- 1. If you are offered employment at one or more of the summer music festivals in Rhode Island in 2019, YOU MAY ACCEPT THE ENGAGEMENT.
- 2. DO NOT SIGN any Individual Player Agreement (IPA), release form, or any other document proffered to you by management.
 - 3. FILL OUT A STANDARD AFM CONTRACT FORM.
- i) Members of Local 198-457 should use the L-1 (Local Engagement) contract form. Members of other locals may use the T-2 (Traveling Engagement) contract form. However, the L-1 contract form is preferred because of its arbitration clauses.

These contract forms are easily downloadable both from the AFM web site and from the Local 198-457 web site (in the members' area). They can be filled out online and printed neatly.

- ii) Calculate all performances and rehearsals that are required for the engagement and be sure that the amount of money you are being offered is AT LEAST the minimum Local 198-457 wage scale for all your performances and rehearsals. (Check with our office if you have any questions.)
- 4. Print TWO copies of the contract, sign both, and mail them to the employer. The employer must sign BOTH copies and return one copy to you.

When you receive the signed copy from the employer, make a copy of it and send it to Local 198-457.

If the employer does not sign the contract, you must inform him/her that you CANNOT perform the engagement.

5. Both Local 198-457 and your own Local (if you are a member of another Local) will be available to assist you with any difficulties. Contact us right away should you encounter any problems.



Resolution Number 2017-07 Eliminate Dues Increase Scheduled for January, 2020

The following resolution was introduced at the General Membership meeting of September 25, 2018, and has been referred to the Finance Committee.

It will be put to a vote of the membership at the next General Membership Meeting on **Tuesday, November 20, 2018**.

A RESOLUTION TO ELIMINATE DUES INCREASES IN 2020

WHEREAS the costs of achieving or maintaining membership have been an obstacle to recruiting new members and to retaining some existing members; AND,

WHEREAS it is necessary to increase the membership in order to generate enough revenue for the Local to perform its functions,

BE IT THEREFORE RESOLVED THAT:

- I) The dues increases scheduled to take effect on January 1, 2020, shall be eliminated;
- II) The periodic dues for regular members shall be capped at 2018 levels, that is \$204.00 per year, or \$51.00 per quarter;
- III) The periodic dues for Life members shall be capped at 2018 levels, that is, \$144.00 per year, or \$36.00 per quarter;
- IV) The Local's By-Laws shall be modified to incorporate these dues changes, as follows:

Weather a Factor

Facing the threat of imminent rainfall, 17 dedicated golfers took part in the Local's annual Golf Tournament at the Alpine Country Club in Cranston, Rhode Island, on Tuesday, September 11.

While thunderstorms raged a few miles away in northern Rhode Island, the golfers enjoyed sunny skies and favorable weather.

Several last-minute cancellations came in from some registered players because of the bad weather in their own neighborhoods.

This year, Brothers Al DeAndrade and Ed DiMartino served as co-chairmen. Brother Lee Bernardo filled the role of Treasurer.

At the banquet following the tournament, prizes were awarded to participants in several categories.

First place finishers were the foursome of Al DeAndrade, Vic Fontaine, John Pagano and Bob

Rossi. Second Place went to the threesome of Lee Bernardo, Arthur Medeiros and David Britt. Third place was taken by the threesome of Roger Boudreau, Jack Boudreau and Keith Demty

Prizes for "Closest to the Hole" went to David Vinacco and Lee Bernardo. Larry Moses and David Britt won for "Longest Drive."

The tournament originally had been planned for Tuesday, September 4 but, because of a scheduling error at the country club, had to be moved back one week to September 11.

Over 30 tee signs were sold for the tournament, producing additional income for the event of more than \$1,700.00.

In total, receipts were \$4,573.00 and expenses amounted to \$2,819.00, leaving the Local with a net profit of \$1,754.00.

August Cavalcade Makes Handy Profit

The Cavalcade of Bands held on August 21, 2018, at Rhodes-on -the-Pawtuxet in Cranston, proved to be one of the more successful summer events the Local has sponsored in some time.

There were 315 paid admissions (not including the dozens of musicians and volunteers who participated) which, together with a popular 50/50 raffle, produced gross revenues of \$5,265.00.

Expenses for the event were a modest \$1,915.00, leaving a tidy profit for the Local of \$3,350.00.

Performers included Dan Ferreira and the Meadowlarks, Al Marano, Vince Carmen, Angela Baccari, Mary Andrews and Bob Mainelli.

Chairman Al DeAndrade extended his thanks to all the musicians who performed and to all the volunteers who helped to make the evening a success.

Annual Budget Meeting to be held on Nov. 20

The Local's annual budget meeting will be held this year on November 20th. The November date is a departure from past meetings, which were always held on the first Tuesday in December. The new date is the result of the resolution passed in April that gave more flexibility in scheduling the meeting.

The 2019 budget, prepared by Secretary-Treasurer Vern Graham, projects income of \$89,332.67 and expenses of \$84,223.78, leaving a narrow gain of \$5.108.89.

In order to establish conservative estimates, the budget is based on a membership total of 250, rather than the current total of 263. If the Local is able to stave off further membership losses, the numbers should remain positive.

A summary of the budget proposal is printed on page 9 of this issue. The full budget proposal is posted on the Locals web site, www.ProMusicRI.org, in the "members area", under "Treasurer's Reports".

The budget meeting also serves as a General Membership Meeting, so all other business of the Local will be taken up at the meeting as well, including a vote on a resolution to eliminate a dues increase scheduled for 2020.

The next Cavalcade of Bands will be held on Tuesday, November 13, again at Rhodes-on-the-Pawtuxet.
