Membership Meeting

Budget Proposal, Dues Freeze, Pass

PRES APPEARS ON CABLE-ACCESS TV

As part of the ongoing efforts to boost the Local's public presence and improve public perception of the Local, President Ed Plunkett made an appearance on the cableaccess TV program *LaborVision*.

The program is sponsored by the Institute of Labor Studies and Research (ILSR). Host James Riley interviewed President Plunkett about the history of the Local, some of its illustrious members, the *Cavalcade of Bands*, and the Local's current and future focus.

The program was broadcast on the "Public, Education, Government" (PEG) channels: Verizon channel 33; Cox channel 14; on six different dates -- February 5th (7:00 PM), 7th (8:00 PM) and 9th (5:00 PM) and February 12th (7:00 PM), 14th (8:00 PM) and 16th (5:00 PM).

Note that the program consists of two segments. The segment about the Local begins approximately 15 minutes into the video.

New Resolutions Introduced

At the Annual Budget Meeting held on Tuesday, November 20th, 2018, members present voted to approve the budget prepared by Secretary-Treasurer Vern Graham.

The budget anticipates income of \$89,332.67 and expenses of \$84,223.78, leaving a modest profit of \$5,108.89.

Graham based his projections on a membership base of 250 members. Although the Local currently has 261 active members, he felt it prudent to prepare for further membership declines, as the downward trend in membership has been going on for several years and will probably continue.

Graham reported that, unlike 2017, the fiscal year 2018 seems to be headed toward a positive finish; i.e., the Local expects to complete the year with a profit. Thus, if the budget projections hold, the Local could have a positive financial result for two calendar years in a row.

Dues Freeze Passes

The members also approved a resolution to freeze the dues structure at its current level.

President Ed Plunkett had sought to lower dues last spring,

but was turned down by the International Executive Board (IEB) of the AFM.

The "freeze" resolution, which he introduced at the September 25th membership meeting, eliminates an increase which had been scheduled for January, 2020, and holds dues to current levels. Since this is not an actual reduction in the dues rate, IEB approval is not required.

Two new resolutions introduced.

Sister Denise Plaza-Martin submitted a resolution to correct a deficiency in Schedule III (Symphony, Oratorio, Opera, Ballet, Chamber Music) of the Wage Scale, which has no scale for a "Leader".

Plaza-Martin's resolution would add a "Leader" scale to Schedule III, at a rate equivalent to side person's scale plus 50%.

President Plunkett introduced a resolution to add four seats to the Executive Board, increasing it from two members to six members. Plunkett pointed out that without the extra seats, it would not be possible to have a true demographic representation of the membership. He added that although we had absorbed two other Locals, there were no representa-

Local Finishes 2018 "In the Black"

After a few years of financial struggles, the Local finished 2018 with a net gain.

Income for the year was \$94,146.15 and expenses totaled \$84,417.24, leaving a surplus of \$9.728.91.

This compares very favorably with 2017, when the Local suffered a loss of \$11.826.47.

Interestingly, revenue for 2018 was actually less than for 2017, by \$5.842.64.

However, concerted efforts by the officers to bring spending under control reduced expenses from \$111,815.26 in 2017 to \$84,417.24 in 2018.

President Ed Plunkett commented, "A lot of hard work went into controlling our expenses in 2018 and the results are evident."

For 2019 he is a little less sanguine: "I don't think there will be any more large deficits like there were in the past. Due to both structural and unanticipated expenses, we may only be able to break even in 2019. But in 2020, the structural expenses will be gone and the Local will definitely see a result on the positive side."

He continued, "Our core problem is the decline in membership. That is the area where the Local needs to focus its attention and resources, to bring new, duespaying members into the Local."

Free Hearing Clinic to be Held on May 15

Our Local, in conjunction with MusiCares, the charitable arm of the Grammy Awards, will hold a free hearing clinic for musicians. May 15 has tentatively been set as the date of the clinic. It will be held at the Local's headquarters in Providence..

The clinic will consist of the custom fitting of special ear plugs to prevent further hearing damage. The ear plugs may be worn on stage, while playing. They greatly reduce the potential harm caused by loud or amplified music.

Each attendee will be customfitted and will receive the ear plugs, a \$250.00 value, for free.

Also a workshop on hearing loss prevention will be held.

The clinic is open to all musicians, both union and nonunion. However, attendees must register in advance with Musi-Cares and must provide proof that they have been professionally employed in the music business for at least five years.

The Local had planned to sponsor a free dental clinic this past fall but, because of state licensing issues, the clinic could not be held.

More information about the hearing clinic will be sent out as soon as all the details are finalized.

While there had been some concern that the event was too late in the season, nearly 300 patrons purchased tickets for the event.

However, *Cavalcade* chairman Al DeAndrade remarked that he had confidence all along in the continuing popularity of the Cavalcade and he actually sees a resurgence in attendance.

Both advance ticket sales and tickets sales at the door were brisk, attracting a lively and enthusiastic crowd.

A popular 50-50 raffle was held, which also contributed to the evening's financial triumph.

In the ballroom the Strictly Sinatra Orchestra, featuring Mike Dutra, performed all the classic Sinatra hits for the audience. They alternated with the Al Marano Sextet, who tapped into the "High Society" band book with a number of crowd pleasers.

The Foyer featured a panoply of small groups -- The Terri Giviens group, The Diane Carey quintet, Dick Lupino (with Mike Renzi and Alan Bernstein), Nancy Paolino and the Black Tie Band, and The Bob Mainelli quintet.

Financial results for the evening showed income of \$4,905.00 and expenses of \$1,872.00, leaving a profit for the Local of \$3,033.00.

The next Cavalcade of Bands is scheduled for Tuesday, April 30, 2019.



Resolution Number 2018-08 Add a Leader Fee to Schedule III of the Wage List

A RESOLUTION TO ADD A LEADER FEE TO SCHEDULE III

WHEREAS the leader fee was inadvertently left off of the Schedule 3 Wage Scale; AND WHEREAS it is necessary to include a leader fee in the Schedule 3 Wage Scale,

BE IT THEREFORE RESOLVED THAT:

- I) The Schedule III wage scale shall be modified
- II) The leader fee shall be added to Schedule 3 Wage Scale
- III) The leader fee shall read as follows: LEADER: Sideperson's fee plus 50%
- IV) The schedule III wage scale shall be modified as follows:

SCHEDULE III

SYMPHONY, ORATORIO, OPERA, BALLET, CHAMBER MUSIC

(excluding collective bargaining agreements)

A. PERFORMANCE: 2-1/2 hours or less \$120

OVERTIME:

per half hour or less, until midnight \$25

B. DOUBLING: 25% additional C. CONCERTMASTER: 25% additional

D. CONTRACTOR: not less than 10% of total scale

LEADER: Sideperson's fee plus 50%

E. REHEARSALS*:

2-1/2 hours or less
 Overtime, per ½ hour, until midnight
 \$25.

3. After 1-1/4 hours of rehearsal,

a 15 minute intermission must be taken.

When rehearsal exceeds ninety minutes

WITHOUT an intermission,

Add (per musician) \$15.

4. Pre-Performance rehearsal on location

A 1-hour rehearsal, no earlier than

1-1/2 hour prior to performance: \$45.

Resolution Number 2018-09 Increase the Executive Board from Two to Six Members

The following resolution was introduced at the General Membership meeting of November 20, 2018, and has been referred to both the By-law Committee and the Finance Committee.

It will be put to a vote of the membership at the next General Membership Meeting on **Tuesday, March 19, 2019**.

A RESOLUTION TO EXPAND THE EXECUTIVE BOARD

WHEREAS over the last seven years the Local has absorbed two other Locals, without always providing recognition or direct representation for the former members of those Locals, AND,

WHEREAS it is necessary to make the Executive Board more representative of the membership – demographically, geographically and professionally; ANA,

WHEREAS the strictness of the election rules has made it difficult, in some instances, for able candidates to qualify for office, AND

WHEREAS it is necessary to recruit younger members to the Executive Board in order to plan for the future of the Local and ensure its survival,

BE IT THEREFORE RESOLVED THAT:

- I) The Executive Board shall be increased from two (2) at-large members to six (6) at-large members;
- II) The stipend for all board members shall be \$60.00 (reduced from \$100.00) per Executive Board Meeting attended.
- III) The Vice-President's stipend shall be \$60.00 (reduced from \$100.00) per Executive Board Meeting attended.
- IV) The additional Executive Board positions shall be filled at the next nomination / election cycle, in accordance with the Local's existing election procedures.
- V) To be eligible for nomination to an Executive Board at-large position, a member shall have been a full member of the Local in continuous good standing for at least six (6) months (reduced from twenty-four (24) months) preceding the nomination meeting; however, to be eligible for nomination to a titled officer position (president, vice-president, or secretary-treasurer), a member must be a full member of the Local in continuous good standing for at least twelve (12) months preceding the nomination meeting (reduced from twenty-four (24) months); a member expelled from the Local shall not be eligible for nomination to any position for a period of eighteen (18) months preceding the nomination meeting (reduced from forty-eight (48) months);
- VI) In order to prevent membership meetings from being dominated by Executive Board votes, the minimum requirement for a quorum shall be increased from 2% to 5%;
- VII) The Local's By-Laws shall be modified to incorporate these changes, as follows:

ARTICLE III OFFICERS

Section 2. VICE-PRESIDENT

(D) The Vice President's stipend shall be \$100.00 \$60.00 for each Executive Board meeting attended.

Section 5. EXECUTIVE BOARD

- (A) The Executive Board is composed of the President, Vice President, Secretary / Treasurer and $\frac{1}{1}$ (6) members at large.
- **(M)** Executive Board members shall receive compensation in the amount of \$100.00 \$60.00 for each Executive Board meeting attended.

ARTICLE IV NOMINATIONS AND ELECTIONS

Section 1. NOMINATIONS

(E) To be eligible for nomination a member must have been a full member of the Local in continuous good standing for at least twenty (24) months preceding the nominations meeting.

To be eligible for nomination to a titled officer position (president, vice-president, or secretary-treasurer), a member must have been a full member of the Local in continuous good standing for at least twelve (12) months preceding the nomination meeting.

To be eligible for nomination to an Executive Board at-large position, a member must have been a full member of the Local in continuous good standing for at least six (6) months preceding the nomination meeting.

Any \underline{A} member <u>previously</u> expelled from the Local <u>is shall</u> not <u>be</u> eligible for nomination <u>to any position</u> for a period of <u>forty-eight (48)</u> <u>eighteen (18)</u> months preceding the nomination meeting.

Section 2. ELECTIONS

(O) The election of officers of this Local shall be by secret ballot, and printed as follows:

Fourth Heading: Executive Committee of two (2) six (6). You are required to vote for at least two (2) people to register your vote.

(P) You are required to vote for all delegate positions to register your vote.

ARTICLE V MEETINGS

Section 3.

- (A) A quorum must be in attendance at a membership meeting for a meeting to be called to order or continued. On all matters relating to amending the Constitution or By-Laws, or the appropriation of funds, 2% 5% of the membership shall constitute a quorum.
- **(B)** Quorum $-\frac{2\%}{5\%}$ of total Local members as Per Capita report filed with the Federation including the Executive Board.

VIII) This resolution shall become effective on January 1, 2020, except that the election of the additional board members shall be included in the Fall, 2019, election cycle.
